

# Mid Coast Equine Wellness Program 2023

## Terms and Conditions

1. Sign-up is from 1/1/2023 through 3/10/2023. **Please note: Submissions must be postmarked no later than 3/10/23.** Enrollment begins at the receipt of complete payment and ends 12/31/2023.
2. There is no carry-over to the following year. If all services offered in your selected plan are not utilized during the enrollment term, there is no refund or substitution.
3. Payment options are as follows:
  1. Full payment at the time of application. We accept cash, check and credit cards.
  2. Payment plan: The full package cost may be divided into 2 equal monthly payments to be paid during the sign-up period. Full payment must be complete before services are rendered.
4. Any services or discounts offered through the wellness program can only be applied to the enrolled horse, except:
  1. If an enrolled horse dies or is sold while participating in the wellness program, a prorated refund will be given or you may transfer the plan's remaining balance to another horse.
5. Selected plan may not be changed during the enrollment term, but may be changed the following enrollment year.
6. Should your horse require advanced dentistry in the Comprehensive or Senior/Metabolic plan, you will be responsible for the difference in price between routine and advanced dentistry. Should your horse require extractions (wolf teeth, molars or incisors), this is not included in either routine or advanced dentistry, and you will be responsible for any additional fees.
7. Thyrotropin Releasing Hormone (TRH) is not included in the ACTH/Insulin testing. If it is determined that a TRH stimulation test would be the most appropriate laboratory test to diagnose or monitor your horse for Cushing's disease, you will be responsible for the additional cost. As of 1/1/2023 the cost for TRH is \$50.
8. The following services are excluded from the wellness program:
  1. Farm call
  2. Additional booster vaccination required in a previously unvaccinated horse
  3. Any other additional services not specified (Lyme vaccination, Strangles vaccination, Coggins test, sheath cleaning, etc.)
